SBRC Request for Increasing Open Enrollment Out (\$0), LEP Instruction Beyond 5 Years (\$3,286.92), and Increased Enrollment (\$88,433.80)

Motion by VanSkyhawk seconded by Miller for Increased Enrollment - The district's administration is authorized to submit a request to the School Budget Review Committee for a modified supplemental amount of \$88,433.80 due to an increase of certified enrollment from the prior year. Limited English Proficient (LEP) Instruction Beyond 5 Years - The district's administration is authorized to submit a request to the School Budget Review Committee for a modified supplemental amount of \$3,286.92 related to the English language learning program for students who have exceeded five years of weighting that are included on the Fall 2024 certified enrollment headcount. Motion carried with all ayes.
